### BHS Presents Legacy Awards

In every town there are people who make a difference, those individuals whose love of their homeland spurs them on to create organizations or engage in a life's work that adds to the character of their community. These people are legacies to their town and the organizations they serve. At the Annual Meeting of the Bedford Historical Society on March 3, 2004, Shirley Bianco, President, presented Legacy Awards to three former Presidents of the BHS.

John P. Renwick, Jr. has spent a lifetime devoted to the Town of Bedford. As a descendant of one of the original proprietors, a lifelong Bedford resident, as well as a resident in the Historic District and local business owner, John took a personal interest in the preservation of Bedford Village and in the activities of the Historical Society to promote what is unique and special about Bedford. He joined the Board of the Society and served as President from 1988 to 1997.

Jim Renwick followed his family's dedication to historic preservation. He served as both Chairman of Buildings and Grounds and President until 1998 when he resigned from the Board in order to serve the entire community as a member of the Town Board. He continues to give us tremendous insight to business vitality in Bedford Village.

In 1999, the Board of the Bedford Historical Society, elected its first female president, Linda S. De Menocal. Linda was President from 1999 to 2003, secretary from 1993 to 1996, serving on the Board for twelve years. Also a resident of the Historic District, Linda brought the historical society into the new millennium by encouraging a greater presence in Town and improved administration of the organization and its buildings and activities.

Each of our Legacy Award recipients now sits on a newly formed Advisory Board so that their collective memory and perspective can help guide the historical society into the future.

## A Note from the President:

The Bedford Historical Society is approaching its 90th Anniversary. In 1916 an unlikely group banded together to preserve a 19th century Methodist Church which was being sold to a developer for conversion into a rooming house. This group saved the church, known today as Historical Hall and founded the Bedford Historical Society.

I call this group “unlikely” because in reviewing our original Articles of Incorporation at our last board meeting, John Stockbridge, our town historian, pointed out that of the nine original signers, five were women. The date of signing was four years before women were granted the right to vote!

The Bedford Historical Society has stayed true to its mission of preservation, education, collection development and interpretation all these years. The membership and leadership have always been “unlikely”. We don’t all have old houses or old family ties to the town. What we all do share is the love of our town’s historic character.

For many years, membership has had only slight growth. I am happy to report that for the first time in decades, we have increased membership by over 12% so far this year. This is a tribute to the hard work of our membership chairwoman and our entire board. This growth of new members will mean that our programs will evolve to match the character and interests of our members.

We still have far to go in membership growth. It is my hope and objective to count at least half of all households in Bedford as members one day. If you are a new member, thank you for joining! If you know of anyone new to town, bring them up to the office and introduce us. I look forward to your continued interest and support!

## Bedford 1787 Court House Garden

Have you ever had an occasion to study a photo taken in your living room or really looked at the amenities in a bedroom in anticipation of houseguests and suddenly realized that over the years the room's condition had deteriorated? We all get used to the status quo, and changes occurring slowly over time are barely noticed. This is what happened to the small garden to the side of the 1787 Court House in Bedford Village. The garden, originally designed by Mimi Lines and installed in 1992, had lost much of its form and appeal. Many of the boxwood, which outlined the garden's symmetry, had died or lost foliage on the lower branches. The espaliered apple on the back fence had grown tall and its 'arms' were above eye-level. The dwarf crab apples needed to be shaped.

The Bedford Historical Society got to work and coordinated the renovation project. Mimi Lines graciously ordered both new boxwood and a beautifully trained espaliered pear, and she oversaw the installation of all the new plantings. She did this completely at cost and donated her time and expertise as well. She even transplanted some of the old boxwood to an area near the post office to fill an empty plot once occupied by a tree.

Jeff Garson, a principal in the Empire Building, graciously replanted the area on the driveway that services the rear of the Empire Building. Without his participation even a beautifully renovated Court House garden would have failed to shine as the adjoining dying shrubs would have detracted from the garden. (Mr. Garson also has replanted the total area behind his building.)

Both the Rusticus Garden Club and the Bedford Garden Club gave substantial financial contributions to help defray the costs. The initial bills are only one portion of the cost as professional pruning will be necessary on at least an annual basis to keep the boxwood, espaliered pear and crab apples properly shaped.

Hugh Vargas who helps the Bedford Historical Society with maintenance replanted the grass and has kept the new plants watered. This is the most important task for the survival of these new plantings. Happily, so far the weather has also cooperated.

We all owe a huge "thank you" to Mimi Lines, Jeff Garson, and to Rusticus and the Bedford Garden Clubs.

The Town of Bedford and the Bedford Village Review Commission approved all the improvements. We hope you do too!

### Wilhelmine Kirby Waller

January 21, 1914 – April 7, 2004

The loss of Mrs. Thomas M. Waller as a dedicated member and supporter of the ideals of the Bedford Historical Society is deeply felt. Known familiarly as "Willie" and renowned for her local and national conservation efforts, she was a dedicated preservationist as well. When in 1990 she placed an extensive conservation easement on the open fields of much of her property, she granted it to the Society. This decision showed her faith in our organization.

In 1978 Mrs. Waller gave the twenty acres on the summit of Guard Hill to the Town. Originally named "Washington Lookout Park," it was rededicated in 1997 as "Wilhelmine Kirby Waller Park."

Her photographs and remembrances were critical to the publication of *Images of America BEDFORD*. She generously spent many hours with the authors Shirley Bianco, President of the BHS, and John Stockbridge, Historian for the Town of Bedford.

In addition to being a national figure in the environmental movement, she was also a nationally acclaimed horsewoman and breeder, especially of Tanrackin ponies. An amusing anecdote: Back in the 1950's she was asked along with Georgina Van Rensselaer and Ruth Sharp to identify some of the young children and horses which were in some of the movies that the BHS had found in its archives. Mrs. Waller confessed that she didn't recognize any of the children, but immediately recalled the names of all of the horses! "Willie" would have laughed with everyone else.

She loved all of God's creatures and Tanrackin Farm constantly revived her spirits. Her death is a substantial loss to Bedford's heritage. Her roots here were solid.
